SCOPE OF SERVICES

Introduction

Presidential Mansioncare, LLC (PMC) is a non-secure residential home facility providing shelter and support services for behavioral health residents who may have a history of serious mental illness (SMI) and who may have completed any mandated incarceration and/or hospital treatment and have been deemed not to be a danger to the community or themselves. Presidential Mansioncare, LLC also provide support, screening and access to services for residents with co-occurring disorders of substance abuse and/or addiction. PMC mission is to assist residents in furthering their treatment objectives, while providing professionally supervised environment to residents seeking safe place to live, and where their activities can be monitored and where they can acquire essential life skills that are essential for activities of daily living and eventual transitioning into the community. PMC philosophy is anchored on Resident services to support and assist a Person or Resident - Centered behavioral health care residential home delivery model and the concept of recovery.

Presidential Mansioncare Services to (SMI) members include, but not limited to wit:-

- A. Provide services where all residents or members are safe and in a clean living environment, food preparation facilities, access to treatment services and therapeutic care in a 24 hour, 7 day a week, 365 days a year behavioral health residential home facility.
- B. Provide services to develop and execute individual treatment Plan and guiding residents towards independence and personal responsibility with cultural diversity.
- C. Provide services to develop positive interpersonal skills for eventual re-integration back into society as constructive and responsible citizens and into their families.
- D. Provide services to educate and teach social skills including personal hygiene, money management/budgeting, and the ability to assertively communicate needs to the appropriate resources in the community.
- E. Provide services with assistance, supervision and monitoring in self-administration of medication.
- F. Provide services to assist residents with planning and arranging access to various services-Educational, Vocational, Therapeutic and aftercare services, physical education and fitness skills.

- G. Provide services of behavioral modification to offer residents an opportunity to live and function in a community environment, while following their specific court-ordered terms, if any.
- H. Provide counselling services for each resident at the frequency and duration prescribed in his/her treatment plan. Counseling may occur in a group setting or individually as stated in the treatment plan. Individual counseling may not exceed one hour every two weeks and group counseling will not exceed one hour every month. Goal oriented Counseling topics for behavioral and emotional issues will be consistent with the program goals and individual treatment plans in such areas as:
 - a. Life Skills: Personal goals, stress management, health issues
 - b. Education: GED, vocational and/or college options
 - c. Personal Development: Values, behavior management, social skills, anger control/management, relationships, and communication skills.
 - d. Therapeutic recreation, and a minimum of 12 hours per week of independent living and social skills support, recreational, rehabilitative treatment.
 - e. Crisis management, substance abuse, relaxation, understanding mental illness.
 - f. Psycho-social rehabilitation depending on resident's need.
 - g. Specialized individual counseling in areas such as post traumatic syndrome and depression by the licensed Behavioral Health Professional Agency-Clinical Supervisor referral.
 - h. Healthy Diet and Nutritional food.
 - i. Substance Abuse Education.
 - j. Social activities and Socialization in the community-Library, Art work, Paintings, Park, Museum, Movie Theater, sporting events, Cultural events, community services, etc.

This agency will not provide family counseling.

Population Served by Presidential Mansioncare:

The service population is males or females ages 18 years and older with serious mental illness diagnosis; and are in full compliance with medication and have minimal basic adult living skills.

Presidential Mansioncare Professional Team

The Presidential Mansioncare teams consist of direct staff and contracted professionals, such as Psychiatric Medical Practitioner, Psychiatric Nurse Practitioner, Clinical Overseer Director, Registered Nurse, Full time/Part time Behavioral Health Technicians (BHTs), Program Director, Behavioral Health Paraprofessionals (BHPP) and Management Personnel's. The superiority of our behavioral health residential services is predicated upon the top-quality of our devoted, committed, well trained, dedicated, educated, well skilled and fully experienced direct staff and behavioral health Professionals, who are willing to go far and beyond the call of duty to serve our clients with respect to their rights and dignity.
